# **Annual Report June 2012**

# 1. Summary of major points.

- The Council has Quality Status and will hold this qualification until 2014.
- The Precept is £68,950. The cost of the Council is lower than 2003 and is less than 31p per house per week.
- The Council provides Heath Hayes Cabin for the use of local groups.
- The Council also provides the Hayes Green Community Centre.
- The Council has an annual grants programme and last year awarded £6,287 to local organisations.

# 2. Introduction.

The Council, in Cannock Chase, Staffordshire, has 13 Councillors representing the four wards of New Heath Hayes, Old Heath Hayes, Hawks Green and Wimblebury. Four Councillors represent Old Heath Hayes and three each for New Heath Hayes, Hawks Green and Wimblebury.

#### 6. Chair's Report - 2011/12 - From the Annual Parish Meeting 18th May 2012 -**Councillor J. Bernard.**

Welcome to the Annual Parish Meeting of Heath Hayes and Wimblebury Parish Council. I am Councillor John Bernard and I am the Chair of the Council. We meet monthly, normally at Heath Hayes Library but once a year, we hold our Annual Meetings at the Hayes Green Community Centre. I will shortly be presenting our awards for Citizen of the Year and Business of the Year and then, our community group representatives will be invited to say a few words. At the end, everyone is invited to have an informal meeting and to speak to Councillors and other representatives over a tea or coffee.

I would like to say how pleased I am to be the Chair of the Council. We are one of only 12 Councils in Staffordshire with Quality Status, the only one in Cannock Chase and we are proud to have held this status since 2006.

The Council would like to congratulate Mr Dave Jillings of the Chase Wado Kai Karate Club based at Five Ways School. Dave is an unpaid volunteer at the club and has been teaching local children for 16 years, training them, preparing them for competition and their success has been amazing. He is a fifth dan and Chief Instructor and he is to be commended on the success of the club, producing regional, national and world champions. This year alone, the club has successfully competed in Derby, Ireland and Japan. The club is a tremendous asset to the area and we congratulate Dave on winning the award for Citizen of the Year.

The award for Business of the Year is made to the Newlife Foundation for disabled children. If ever there was a business that deserves public accolade it is Newlife. Based in Hawks Green, Heath Hayes, this charitable foundation recycles products and raises money for charity. Founded in 1991 and based in Heath Hayes, they fund nurses and equipment, campaigns and medical research. Items donated by companies are recycled and the business is very popular and useful for shoppers as well as the beneficiaries.

Newlife has donated  $\pounds 7$  million for equipment and  $\pounds 12$  million for medical research. Last year alone, £2.2 million was donated and since 2005, over £630,000 has been given in grants to families in Staffordshire. Congratulations and thanks to Newlife.

Now, a brief report about the Council and what we do. There is a fuller list on your seats, but here are a few points:

We run the Heath Hayes Cabin on the Hednesford Road and have kept the hire charges frozen for three years.

This Community Centre has also had the hire charges frozen and is in use every day of the week.

Last year, we delivered a map of the area to every house. This had information about the history of Heath Hayes and Wimblebury and was funded through grants, not costing the residents at all.

Last year, we continued our grant scheme and donated over £6,000 to local groups and we continue to support organisations that benefit the area.

We continue to operate a website and Facebook page, administered without cost and has agendas and minutes, as well as many other articles and links.

As a Council, we provide the best value that we can. We keep the tax burden as low as possible and the precept is lower than it was in nine years ago. Because of the money we raise, over the last six years, we have brought over £120,000 more into the area than we have had in tax. We continually look at ways to save money and to obtain outside funding for our projects as well as assisting other groups with information.

We have had a lot of success in the last few years and I hope that the next year will continue to be as successful and that we continue to be a benefit to the area. I would like to thank the Councillors for their work over the last year and to thank you all for allowing me to serve as Chairman.
