
2.2 Heath Hayes Cabin – water supply.

- JGM Karate. Monday and Wednesday 5pm x 9pm.
- Helen O'Grady. Saturday mornings 11am to 12 midday. It had been noticed that the hire classes were regularly exceeding the hire period. The classes are run by lesher and there were several requests for her to book and pay for the hours use and to not change them without notice. It was quite clear that she was telling the parents one time and us another. She was told that the bookings would be put on the front door and other hirers would be in the Centre after her booked time so she ceased using the Centre,
- The Cherished Coffee Shop has offered to hire the Centre from 11th January onwards from 10am to 3pm at an initial rate of £30 a session for four weeks and then up to £50 a session. We have hired the Centre out for parties on Saturdays and these can still be accommodated but are a lot more work with cleaning and administration for one off bookings. This is also a better financial option for the Centre as the CCS will operate probably 50 weeks a year but the previous class was only operating a maximum of 38 weeks. Parties can still be held after 3pm and on Sundays.
